#### **PUBLIC COMMENT**

#### **ACTION ITEMS**

**Financial Report.** Cindy Sproles reviewed with the Board the Financial Report for the period ending August 31, 2008. After discussion, motion was made by Director Caudle, seconded by Director Baxter and carried approving the Financial Report as presented.

**Request Approval of the 2008-2009 Budget.** Cindy Sproles reviewed with the Board the tentative budget for this fiscal year. After discussion, motion was made by Director Hearron, seconded by Director Cox and carried approving the 2008-2009 budget.

#### INFORMATION AND DISCUSSION ITEMS

**Monthly SISC PPO Trend History Through August 2008.** John Stenerson reviewed the monthly SISC PPO Trend history through August 2008 with the Board. John discussed how the last three months have been right around 6% which is still slightly below trend for the market. The numbers are right in line with what we expected.

**Show the Board a Letter from a Member on Balance Billing.** Director Bigler reviewed a letter with the Board from a member describing their trip to the emergency room and the bill they received. Director Bigler discussed balance billing with the Board and the difference between Par and Non-Par providers and what they can charge.

**Update the Board on the California Health Care Coalition.** Director Bigler discussed the mission and goals of the California Health Care Coalition with the Board and also reviewed a list of members including SISC as well as the California Education Coalition for Health Care Reform.

Show the Board an Article for the <u>Wall Street Journal</u> on Wellpoint, Inc. Director Bigler discussed this article regarding Wellpoint's (the parent company of Blue Cross) price strategy. The article discussed how Wellpoint is having a difficult time charging enough to keep stockholders happy while not losing members. Director Bigler discussed the difference between "Self" insured and "Fully" insured with the Board, and since we pay our own claims, what happens to Wellpoint stock doesn't effect us.

**Update the Board on SB 840.** Director Bigler reviewed Single Payor (SB 840) with the Board notifying them that it has passed both houses and is on the Governor's desk. We would expect the Governor to veto it as he did before. Director Bigler also reviewed Universal Health Care with the Board. The concept being that everyone would be covered but the delivery system would remain pretty much as is.

**Show the Board a Newspaper Article on Medical Re-pricing.** Director Bigler reviewed this article from the <u>L.A. Times</u> on the difference between what Doctor's bill and what the insurance pays.

**Review the Investment Policy.** Director Bigler reviewed our current investment policy with the Board and, given the country's current financial situation, asked for an open discussion from the Board Members to determine whether or not we should continue with our investments as is. After discussion, the Board said it was comfortable with our current investment policy and diversification.
