## **PUBLIC COMMENT**

### **ACTION ITEMS**

**Financial Report.** Cindy Mattern reviewed with the Board the Financial Report for the period ending October 31, 2008. Cindy pointed out that the LAIF rate for the month of October was 2.71%. Cindy also discussed the annualized returns of the SISC Investment Pool, Wachovia Securities and Merrill Lynch with the Board. Fred Bayles of Wachovia Securities and Rich Edwards of Merrill Lynch discussed "annualized return" and "yield to maturity" with the Board. Cindy also reviewed with the Board the quarterly investment report and the revolving fund expenditures. After discussion, motion was made by Director Cox, seconded by Director Hearron and carried approving the Financial Report as presented.

**Request Approval of the 2007-2008 GASB 45 Audit.** Megan Hanson reviewed this audit with the Board. Megan let the Board know that the current portfolio value is \$62,000,000.00. After discussion, motion was made by Director Cox, seconded by Director Scott and carried approving the 2007-2008 GASB 45 Audit.

#### INFORMATION AND DISCUSSION ITEMS

**Monthly SISC PPO Trend History Through October 2008.** John Stenerson reviewed the monthly SISC PPO Trend history through October 2008. John informed the Board that our numbers have been fairly consistent, between 5 and 6% and are currently at a 5% year over year trend.

Show the Board an Article on How I.T. will Effect the Future Delivery of Health Care. John discussed this article with the Board regarding the involvement/advances of technology within the health care industry.

Show the Board a Press Release from the Department of Managed Health Care on Balance Billing. John discussed this article with the Board and informed them that the article is only referring to HMO, however this has been an issue for quite awhile. John let the Board know that SISC does attempt to actively act on behalf of members to intervene when this issue arises.

Show the Board an Article regarding an Interview with Lloyd Dean. John reviewed this article with the Board regarding an interview with Lloyd Dean, Chief Executive Officer of Catholic Healthcare West. John explained the difference between Single Payor and Universal Healthcare to the Board and reviewed the Governor's plan on health care reform.

Show the Board an Article on the Obama Health Care Plan. John reviewed this article with the Board which discusses how President Elect Obama may find it difficult to overhaul the health care system with the current financial crisis.

**Update the Board on SISC's Wellness Program.** John reviewed the wellness program with the Board. John informed the Board Members that Condition Management has been going on for a year. Nurses are calling members with issues and providing telephonic coaching. Account Managers have been getting out to districts to discuss the program. Members will now be offered a \$25 gift card to participate in health screenings. Districts will need to request the screenings and commit to having members attend. A question was posed about where the information from the screenings would go, and how it would be used. Several Board Members discussed member concern about their personal health information being shared or used to increase rates in the future. John discussed the possibility of sending a letter to members explaining the program and how the numbers will be used.

Discuss the "Dispense As Written" Program that Became Effective October 1, 2008. "Dispense As Written" program and reviewed with the Board the reasons it was proposed in March. Director Hearron let John know his District has received complaints, both about the program itself as well as the difficulty members are having going through the appeals process. Director Hearron further discussed his concerns with taking the decision out of the Doctor's hands. Gary Rice with Greenfield expressed similar concerns, adding that the CTA is starting to weigh in and Schools Legal has been asked to look it over. Mr. Rice let John know he was uncomfortable with members being forced to make financial decisions while the appeal process is moving forward. He believes that the theory is good but that we should have a balance between cost containment and member satisfaction. John let the Board know that we had not heard any complaints about the appeals process, and that if there were issues we would deal with them immediately. We view ourselves and advocates for the districts and members. Mr. Rice and Director Hearron both reiterated their concern over taking the decision away from the prescribing Doctor. John discussed the overwhelming evidence that Dr.'s are prescribing based on patient request or pharmaceutical sales rep. Several Board Members stated they believed the appeals process to be the problem and not the plan itself. Mr. Rice requested that SISC send a letter to members describing the appeals process along with a SISC number to call with any questions. John committed to sending out a letter in a week. It was decided to bring this issue back as a discussion item next month for review.

**Comments From the Board of Directors.** There were no comments from the Board members at this time.

#### **ADJOURNMENT**

There being no further business to come before the Board, motion was made by Director Scott, seconded by Director Hearron and carried adjourning the meeting at 2:40 p.m.
